

Together, we purchased and moved into our beautiful new JLD Headquarters in the Golden Triangle area on March 25, 2016. A huge thank you goes out to our Second Time Shop Staff, as well as all members that served on our Second Time Shop Committee and Second Time Shop Special Committees to handle all the details around the closing, including a wonderful celebration on March 19, 2016.

Additionally, we continue to plan for the future by completing a comprehensive 2016–2021 Strategic Plan, in time for our 100th Anniversary in 2018–2019. The plan will be implemented this year. We're confident that we are poised for not only an incredible 100th Anniversary celebration, but also for the future.

The JLD and JLD Foundation Boards continue to work together to streamline our fundraising efforts to be more efficient and have greater transparency. We are so grateful for the \$279,500 distribution we received from the JLD Foundation in 2015–2016, representing approximately 25% of our total operating budget. We simply could not do it without our beloved Foundation, and remain forever grateful for the talented women that started our endowment in 1992 with the sole purpose of supporting the Junior League of Denver into perpetuity.

Concurrently, our community programs, fundraisers and training programs were all highly successful. We encourage you to read more about our myriad of accomplishments this past year in this report.

When women from every background give their time, talent, energy, and money to educational and charitable activities, they can drastically improve the quality of life in our community and in our world. We are those women. We are the Junior League of Denver.

WHO WE ARE

The Junior League of Denver is a women's training organization that develops civic leaders committed to improving our community. We are currently working to improve literacy rates in the Denver metro area, for children from birth through third grade. Founded in 1918, the League started many well-known Denver institutions including the Children's Museum of Denver, the Mile High Transplant Bank and the Red Rocks concerts.

JLD FOUNDATION

In 1992, our members had the vision to create one of the first ever Junior League Foundations, to guarantee sustaining our mission long term. Thanks to their wisdom, the Foundation now provides approximately 25% of the League's annual operating budget every year. The greatest needs in our community will change, but our commitment to developing women into trained volunteers ready to address the greatest needs will *never* change.

The JLD Foundation investment portfolio was valued at \$6,871,000 on May 31, 2016. In 2015–2016, the Foundation funded a distribution to the JLD in the amount of \$279,500, the largest distribution to date. This distribution is given in accordance with JLD Foundation Polices to be expended as the JLD Board determines.

The JLD and JLD Foundation continue to work together on a combined strategic model to streamline our fundraising efforts in order to be more efficient. To that end, members are encouraged to make gifts, no matter what size, to the JLD and/or the JLD Foundation.

Our goal is to create a "culture of philanthropy" where members give what they can, when they can, in a way that honors an individual member's personal giving goals. Cumulative contributions in support of the JLD and/or JLD Foundation are reflected in this report.

TWO WAYS TO SUPPORT THE JLD

IMMEDIATE IMPACT

When our members support the Junior League of Denver directly, we support the immediate needs of the League and the community programs we support. Membership dues alone are not enough to pay for all that we aim to accomplish. And while we are extremely fortunate to have the support of our Foundation, our growth is more sustainable when that support is paired with fundraising for immediate needs. Gifts made directly to the Junior League of Denver have been put to work today funding our mission-driven expenses.

FOUNDATION INVESTMENT

When we support the Junior League of Denver Foundation, we make sure the League will be strong now as well as for our daughters and granddaughters. Gifts to the Foundation have a multiplying effect because we not only support our current members who directly touch the lives of children in our community, but we also support the training of future civic leaders and skilled community volunteers. Our members ensure that our legacy of developing women to become impactful civic leaders and skilled volunteers will live on for generations to come.

In our 98-year history, the Junior League of Denver has been known for identifying the greatest needs of our community and developing solutions to meet them, from healthcare, to the arts, to the needs of our children in Denver.

Today, we are making a difference in the lives of children (ages birth through third grade) by promoting literacy. ROCKY MOUNTAIN PBS KIDS FUN FEST

The JLD proudly participated in the Rocky Mountain PBS Kids Fun Fest on Saturday, September 12, 2015 in downtown Denver. For the second year, Done in a Day volunteers distributed about 2,000 books and healthy snacks to children and their parents. The JLD booth was very popular, boasting a line for most of the event. More than 8,500 attendees came out for the kid-centric event to see Curious George, Clifford, and of course, to receive a FREE age appropriate book and snack from the JLD! ONE BOOK 4 COLORADO

The JLD provided a \$10,000 sponsorship to One Book 4 Colorado for the fourth consecutive year. More than 75,000 copies of *Giraffes Can't Dance* by Giles Andreae and illustrated by Guy Parker-Rees were distributed to every four-year-old in Colorado April 11–25, 2016. 2015–2016 COMMUNITY PROGRAMS

- Done in a Day: Providing volunteers to nonprofits for short-term projects throughout the Denver metro area. We completed 157 Done in a Days shifts, and members spent 2,609 hours on Done in a Days in the community.
- Little Free Libraries: The League placed 18 Little Free Libraries for placement at community centers throughout the Denver metro area. It's a "take a book, return a book" gathering place where people can share literature and stories.
- The Gathering Place: We served approximately 5,000 meals between September 2015 and May 2016 at Denver's only daytime drop-in shelter for women, their children, and transgender individuals experiencing poverty or homelessness.
- Kids Connect: Bimonthly family literacy-based program centered on early childhood brain development. The program, held at both Sewall Child Development Center and Children's Outreach Center in 2015–2016, was designed and implemented by the JLD. About 510 children and their caregivers were served at 26 program nights at each location with more than 250 books distributed.
- Tutoring with Kids: The JLD provided one-on-one tutoring for Reading Partners Colorado and TutorMate, an online literacy program that helps kids improve reading abilities.
- Read2Kids: An event-based program promoting literacy through access to books and parental/ caregiver involvement. The JLD served 11 partner schools. Volunteers distributed approximately 1,480 new books to more than 450 kids, ranging from preschool to sixth grade. Our partner profile targets Denver metro area schools with 85%+ of students qualifying for free or discounted lunch.

PUBLIC POLICY & ADVOCACY

The JLD has a proud history of public policy and advocacy. We were the first League to hire a government affairs consultant in 1987. The Public Policy Council works closely with the consultant to monitor, advocate, and support various pieces of legislation. The League has supported policy addressing literacy issues, child health issues, women's health issues, and women's self-sufficiency issues. The Public Policy Council also hosts several training opportunities throughout the year to educate the membership on key issues facing our state, as well as the election process. Questions? - Hosted more than 20 legislators for Annual JLD Day at the Capitol in February 2016
- Organized and hosted University League training on Pay Equity and Salary Negotiations for Women
- Expanded community partnerships with Colorado Children's Campaign, Children's Hospital Colorado and Florence Crittenton Services
- · Initiated discussions about JLD signature legislation and advocacy work on Affordable Child Care
- Awarded two Legislator of the Year awards to Representative Brittany Pettersen (D-Lakewood) and Representative Faith Winter (D-Westminster)

JLD MEMBER TRAINING

In addition to the experiential training our members receive through various placements and projects, the JLD features a Training Council that provides a variety of learning and enrichment opportunities for our members, serving the very heart of our mission. Questions? Email training@jld.org.

Our Training Council consists of the following committees:

- Active Advisor Committee: New for 2016–2017, this committee assists with the transition from Provisional to first year Active. Active Advisors act as mentors and facilitate members developing new skills to use within and outside of the League. The committee facilitates newer members with a peer learning group and an opportunity to explore the possibilities of their JLD experience.
- General Meetings: Led by the JLD President and General Meeting Chair, these events feature inspiring keynote speakers, advocacy training, and much more. General Meetings serve as a member touch-point and networking opportunity.
- Leaders In Action: These trainings focus on the development of our members who are leading councils and committees, with a focus on core leadership competencies, soft skills, and peer learning.
- Leadership Institute: Member placement that provides focused personal and professional development. JLD members are selected through an interview process and participate in regular courses throughout the year. The intent is for the members to take on leadership positions after successful completion of this holistic education for nonprofit leadership.
- Talent Management: This committee provides specific training to give women the skills they need to be successful in their League placements. Examples include literacy training for Read2Kids members and fundraising techniques training for Journey committee members.
- University League: These enrichment courses focus on a wide variety of topics ranging from interior design, auto maintenance, career performance enhancement, home buying, women's health, and new topics each year.

*This amount includes a distribution of \$279,463 and a reimbursement of JLD operating expenses of \$50,000.







SAYING FAREWELL TO SECOND TIME SHOP, A DENVER INSTITUTION AND JLD FUNDRAISER



The Junior League of Denver Second Time Shop, first known as Second Hand Rose, has served the community since 1973. Originally located in a one-story stucco building on the west side of Broadway, just north of I-25, the store has since moved to several locations throughout the metro area.

In 1980, the name was changed to Second Time Shop and the store moved farther south on Broadway in an effort to be more accessible to thrift shoppers. The following year a fire broke out inside the store, burning it down and forcing another move. The shop then moved to 3372 South Broadway, before moving again in 1991 to 351 West Girard. In 2005, the Shop was moved a final time to its current location at the Happy Canyon Shopping Center.


