

Safety First Guide for The Journey

Current JLD COVID-19 Operating Plan Summary:

With the daily changes and the rising COVID-19 cases, safety remains a top priority for the League. Per <u>current public health orders</u> for the City and County of Denver, masks are required indoors regardless of vaccination status with the extension of the mask mandate through February 3, 2022, so we will continue to require that masks be worn at all League meetings and events.

We will also continue to follow any additional requirements of our event venues.

COVID-19 Safety Precautions for The Journey:

The Journey will be held in-person. At our speaker's request, there will not be a virtual option this year.

To comply with the current mask mandate in place, **masks will be required** when not eating and drinking. Masks will also be required when dancing.

If you test positive within 5-7 days of The Journey, you can request a refund or transfer your ticket to a friend. Email <u>journey@jld.org</u>.

At the event, the check-in process will allow us to provide **contact tracing** as needed. If you're a JLD member planning on attending, please be sure you've reviewed and signed our <u>JLD COVID-19</u> <u>Liability Form</u>. For non-members, this form will be available on the GiveSmart platform during the check-in process.

We will be providing a **self-selected** color-coded bracelet to help indicate your personal comfort level with social distancing and interacting during the event.

Hyatt's regulations and safety precautions:

The Hyatt follows CDC recommendations, as well as any city/state requirements, including the current mask mandate. The hotel has also implemented additional cleaning and safety precautions: <u>Downtown Denver Hotels | Hyatt Regency Denver at Colorado Convention Center</u>

Per the Hyatt's current guidelines, our event does not require proof of vaccination at this time as The Journey is a seated event and the estimated attendee count is less than 500. We will have social distancing, cleaning, sanitizing and mask requirements in place during all phases of the event.

For all attendees, the bar will offer touch-free payment options.

Silent auction bidding, paddle raise participation and credit card payments will all run through the GiveSmart platform, which provides a 100% touch-free process.

The JLD kindly asks all attendees to follow the guidance provided by the City and County of Denver and the Hyatt.




Are you well?
