The forms are reviewed by the President, Vice President of Finance and Operations, Treasurer, and the Director of Finance and Operations for possible conflict of interest implications. The signed forms are retained as part of the League's files. Due diligence is exercised when signing contracts or checks for goods or services for possible conflict of interest issues. In addition, board members are asked to disclose any conflicts or perceived conflicts at the beginning of each board meeting.

The Board of Directors, in fulfilling its responsibilities for overseeing the League's compensation policies, plans, and benefits programs, relies on the Standing Committee. The Committee is comprised of the President, President-Elect, Vice President of Finance and Operations, and the Treasurer, all of which are volunteer members of the Board of Directors. The committee reviews and validates the compensation philosophy and strategy, determines annual compensation level percentage changes using such criteria as a) functionally comparable positions; b) availability of
